A.R.R.O: What We Do ?

Advocacy: We advocate on behalf of ex-offenders and their families with the challenges they face upon returning to the community. Our success rate is 85% We don't believe that your worst mistakes defines you.

Re-entry: We assist ex-offenders to navigate the barriers they face when returning to their communities from incarceration. Part of this assistance includes special programs such as: AA, Anger Management & Cognitive

Behavioral Thinking.

Resources: We connect ex-offenders and their families with quality resources in the following areas including but not limited to identification, housing, employment, medical coverage, mentoring, and transportation.

Outreach: We reach out into the community through canvassing, coalition memberships, and hosting events to put us in direct contact with our community and those in need.







ONE STOP SHOP



ARRO and MSU Human Resources have a hance a Pressentiv collaboration called Spartan Fair Chance. This

program provides employment training, workshops, resumes, as well as Apprenticeship opportunities, ARRO has an on the job training for lawn care and snow shoveling.

ARRO has been a leader in advocating for law changes and ordinances that reduce barriers for clients involved in the Criminal Justice system. ARRO was the leader in the Ban the Box/Fair Hiring Legislation. ARRO was also instrumental in the changes in Drivers Responsibility and Food Stamp issues. AR-RO also advocates for Child Support, ID document issues, expungements, Child Protectives Services, Drivers License restoration, social security or any other barrier our clients face.

ARRO has four programs based on eligibility. We have our Re -Entry program for clients who have been in the Criminal Justice System. **ARRO** also has a Day Reporting Program utilized by probation officers as an alternative to prison and jail. Clients must attend three days a week three hours a day as they phase down while completing their goals. This requires a referral from probation.

After an in depth assessment with the help of COMPAS, ARRO determines exactly what each client needs to work toward success. Services include but not limited to:

Medical insurance including setting up Plans and Doctor appointments, medications, Food Stamps and Food packages, ID Documents, ID, Driver License, Transportation options of bus passes and bikes, Glasses, Dental assistance, Clothing Vouchers, Housing assistance (including Advocating for denials). GED and High School Diploma assistance with a teacher on site, WBTM Women's Group, Restorative Justice, Family Reunification, Trauma Therapy, Grief Counseling, Cognitive Behavior groups including Thinking for a Change, Conflict Resolution, Anger Management, Life Skills, Financial Literacy, Dialectical Behavior Therapy, Seeking Safety, Community Service

ARRO'S CONTRIBUTION TO BEING SMART ON CRIME

When ARRO was created, it was created because we saw the barriers that society put in the way of those that "made a mistake". We found a community that had unwarranted fears or families with shame if someone in their family was a felon.

We have spent the last ten years working to change perception and work to change the dynamics in our criminal justice system. It was time to get "smart on crime", keeping our streets safe while we keep families together. The trauma we found in our community is atrocious We found that 87.5% of our clients had been in foster care or adopted, while 85% of those clients had a parent incarcerated.

It was these statistics and stories that found us with Legislators to work to change laws on Specialty Courts. It was here **ARRO** created two additional programs: **ARRO** is part of the team in Mental Health court where our success with clients has been amazing, we also provide services to the Swift and Sure Probation Program (SSSPP) where clients receive the same services as day reporters,
